**Annual Year End Report (as of 12/31/2020):**

- Income from donations: \$9,362.00 compared to last year's \$12,824.00 (down about 27%).
- Expenses: \$5,240.47 compared to last year's \$2,243.74 (up about 134%).
  - Professional Fees: 25.00 (State Corporation Filing Fee: \$25.00).
  - Ministry Expenses: \$39.47 (Church Supplies: 39.47).
  - Dues and Subscriptions: \$176.00 (Yearly PO Box Rental Fee).
  - Publishing Expenses: \$5,000.00 (Books).
- Total Cash Flow: \$4,121.53
- Net Ordinary Income: \$4,121.53 compared to last year's \$10,580.26 (down about 61%).
- Cash in Bank: \$21,523.11 compared to last year's \$17,401.58.

**Vision Moving Forward:**

- Again, we continue to believe God for our ministry building.
- We will continue to look for service projects and partnership opportunities in the Community to promote awareness for and to grow the ministry.
- While the website has been updated, we will continue to look for ways to improve it.
